## Wheelabrator Kemsley announces new funding scheme for community projects

### Applications invited from local groups and organisations

**KEMSLEY, ENGLAND – 25 January 2018** – Industry leading energy-from-waste operator and developer, Wheelabrator Technologies, has launched a new £50,000 community benefit fund to be awarded locally over the next two years. Now, charities, local community groups and organisations are being invited to apply to the Wheelabrator Kemsley (K3) energy-from-waste facility for funding to help boost community projects in Kent and the South East.

"Wheelabrator Technologies is committed to playing an active role in local communities supporting and investing in civic and charitable organisations, local schools and environmental causes, while contributing to increased economic growth and enhanced quality of life in the communities in which we operate," said Wheelabrator's UK Managing Director Paul Green. "As an engaged community partner, we believe our social responsibility begins with the communities in which our facilities operate and our customers and employees live. We look forward to making a positive contribution to our near neighbour communities."

Wheelabrator Kemsley's community benefit fund will support organisations and initiatives that benefit communities nearby to the Wheelabrator Kemsley (K3) energy-from-waste facility in Kent. £25,000 will be awarded in 2018 and the remaining half of the fund will be awarded in 2019.

Wheelabrator Kemsley (K3) is a combined heat and power facility which will generate ~ 50MW (gross) of clean, sustainable electricity to power UK homes and businesses. Once operational in 2019, the merchant facility will be able to process up to 550,000 tonnes per year of post-recycled waste provided by a range of waste management companies from across Kent and South East. This is waste that would otherwise have been sent to a landfill or been pre-treated and exported to Europe.

Due to the facility's location, Wheelabrator Kemsley (K3) will also provide valuable steam heat to the adjacent Kemsley Paper Mill, owned and operated by DS Smith, which will help diversify the mill's long-term energy requirements.
